Golf Cart Permit  
Equipment Checklist

- Slow moving vehicle emblem per MN Statutes 169.522.
  - Orange or blaze pennant extending five (5) feet above the bumper of the cart when operated on a City street.
  - Brakes adequate to control the movement or to stop under all conditions.
  - Equipped with an operational parking brake.
  - Rearview mirror to provide driver with adequate vision to the rear.
  - Reflective material no less than 3"x3" on all four corners of the cart.

Authorized Use of Motorized Golf Carts  
On Roadways of All Streets

- Permit obtained from Foley Police Department, affixed to cart, easily visible at all times
- Possession of proof of insurance while operating golf cart
- At least 18 years of age holding a valid driver's license
- Equipped with slow moving vehicle emblem; brakes; rearview mirror and reflective material on all four corners
- May only operate from sunrise to sunset and shall not operate in inclement weather or when visibility is impaired
- Operates on designated roadway having all the rights and duties applicable to the driver of any other vehicle under the provisions of MN Statutes Chapter 169
